

## **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to all websites and mobile applications owned and operated by Runtime Entertainment, LLP and governs data collection and usage. By using any of the Runtime Entertainment LLP websites and mobile applications, you consent to the data practices described in this statement.

### **Collection of your Personal Information**

To better provide you with products and services offered, Runtime Entertainment LLP may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase Runtime Entertainment LLP's products or services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Runtime Entertainment LLP may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender
- Race

Runtime Entertainment LLP, specifically the Destination Duck mobile application, may also collect the following location information:

- Fine and rough geolocation data
- latitude and longitude coordinates

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

### **Use of your Personal Information**

Runtime Entertainment LLP collects and uses your personal information to operate and deliver the services you have requested.

Runtime Entertainment may also use your personally identifiable information to inform you of other products or services available from Runtime Entertainment LLP and its affiliates.

### **Sharing Information with Third Parties**

Runtime Entertainment LLP does not sell, rent or lease its customer lists to third parties.

Runtime Entertainment LLP may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is transferred to the third party. - The categories of personal information that we disclosed about you for a business purpose.

You have the right under the California Consumer Privacy Act of 2018 (CCPA) and certain other privacy and data protection laws, as applicable, to opt-out of the disclosure of your personal information. ### **Tracking User Behavior**

### **Automatically Collected Information**

- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;

- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

### **Children Under Thirteen**
